

**CoPilot “Win a CoPilot Summer Travel Navigation Pack with Maps of your Choice!”
ALK Technologies Ltd, Sweepstakes: Terms and Conditions**

1. Eligibility: CoPilot “ Win a CoPilot Summer Travel Navigation Pack with Maps of your Choice!” Sweepstakes (entitled “ Win a CoPilot Summer Travel Navigation Pack with Maps of your Choice!” also called “**Sweepstakes**”, are open only to individuals who are 18 years of age or older and have physical mailing address (no P.O.BOX). Employees of ALK Technologies, its advertising or promotion agencies, those involved in the production, development, implementation or handling of this Sweepstakes, any agents acting for, or on behalf of the above entities, their respective parent companies, officers, directors, subsidiaries, affiliates, licensees, service providers, suppliers any other person or entity associated with Sweepstakes and/or the immediate family (spouse, parents, siblings and children) of each such employee (collectively “**Sweepstakes Entities**”), are not eligible.

2. Agreement to Terms and Conditions: Participation in Sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of these Terms and Conditions and the decisions of ALK Technologies (the “**Sponsor**”), which are final and binding. Winning is contingent upon fulfilling all requirements set forth herein.

3. Entry Period: The Sweepstakes start on 23rd July and end on 10th of August 2015 (the “**Entry Period**”).

4. Prize and Territory election: The main residence (“**Main Residence**”) of the Participant shall delimit the Sweepstakes Prize (the “**Prize**”). The Prize of the Sweepstakes is a CoPilot Premium app, Great Shield Flex Grip Universal Car Mount and USB car charger.

5. Sweepstakes Entry/Submission: To enter the Sweepstakes follow directions on the applicable CoPilot Live Blog (<http://blog.copilotgps.com/uk/> or <http://blog.copilotgps.com/na/>). The use of any agencies or automated software to submit entries will void all entries submitted by that person. Only one participation is allowed per physical person.

6. Winner Selection: Winner(s) will be selected via random drawing. The odds of being selected shall depend on the number of eligible entries received. Potential winner(s) will be contacted via email and will be asked to provide their first and last names, age, and main residency address. If a potential winner does not respond within the timeframe stated in the notification or has entered more than once, the Sponsor may select an alternate potential winner in his/her place at random from all entries received during the Entry Period.

7. Requirements of the Potential Winners: Except where prohibited, the potential winner(s) may be required to complete and return an affidavit of residency, eligibility and liability/publicity release (the “**Affidavit/Release**”) within seven (7) days of being notified. If a potential winner fails to sign and return the Affidavit/Release within the required time period, an alternate entrant may be selected in his/her place.

8. Prize(s): The prize(s) are located on the CoPilot Live blog page (<http://blog.copilotgps.com/uk/> or <http://blog.copilotgps.com/na/>). No cash or other substitution may be made, except by the Sponsor, who reserves the right to substitute a prize with another prize if the prize is not available for any reason as determined by the Sponsor in its sole discretion. General Conditions: In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason, including, but not limited to fraud, virus, or other technical problem, the Sponsor may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Terms and Conditions; or (b) award the prize at random from among the eligible entries received up to the time of the impairment.

In case of a dispute as to the owner of an entry, entry will be deemed to have been submitted by the authorized account holder of the screen name from which the entry is made. The authorized account holder is defined as the natural person with proof of Main Residence, who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

10. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages SPONSOR AND ITS SWEEPSTAKES ENTITIES SHALL NOT BE LIABLE TO YOU: IN RESPECT OF ANY CLAIM, DEMAND OR ACTION, IRRESPECTIVE OF THE NATURE OF THE CAUSE OF THE CLAIM, DEMAND OR ACTION ALLEGING ANY LOSS, INJURY OR DAMAGES, DIRECT OR INDIRECT, WHICH MAY RESULT FROM THE USE OR POSSESSION OF THE INFORMATION OR THE SWEEPSTAKES; OR FOR ANY LOSS OF PROFIT, REVENUE, CONTRACTS OR SAVINGS, OR ANY OTHER DIRECT, INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF YOUR USE OF OR INABILITY TO USE THIS INFORMATION OR THE SWEEPSTAKES, ANY DEFECT IN THE INFORMATION, OR THE BREACH OF THESE TERMS OR CONDITIONS, WHETHER IN AN ACTION IN CONTRACT OR TORT OR BASED ON A WARRANTY, EVEN IF SPONSOR OR SWEEPSTAKES ENTITIES HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. SOME STATES, TERRITORIES AND COUNTRIES DO NOT ALLOW CERTAIN LIABILITY EXCLUSIONS OR DAMAGES LIMITATIONS, SO TO THAT EXTENT THE ABOVE MAY NOT APPLY TO YOU.
